TRIO Lawsuit Settled!!!

Post Office Litigation Settled On Courthouse Steps!!

The long-festering feud between **THE TRIO** and the United States Postal Service finally came to an end in late February. The dispute, over **TRIO** flyer delivery, had forced **THE TRIO** to file a lawsuit to resolve the matter. Terms of the settlement were not disclosed.

TRIO "spin doctors" hailed the agreement as a major victory and expressed great satisfaction in "bringing the government to its knees". Investigative reporters for the **TRIO NEWS** have since learned however that basically in return for **THE TRIO** dropping the lawsuit, the Postal Service agreed to continue to accept mail from the group.
